- Influence the behaviours of our suppliers and our contractors through active selection of those with good environmental credentials.
- Enact energy efficiency objectives, for instance to reduce energy and water consumption by 5%, and measure resource consumption to meet improvement targets.
- Use employee or stakeholder feedback to reassess policy and performance considering changed regulatory, environmental, social, or ethical requirements.
